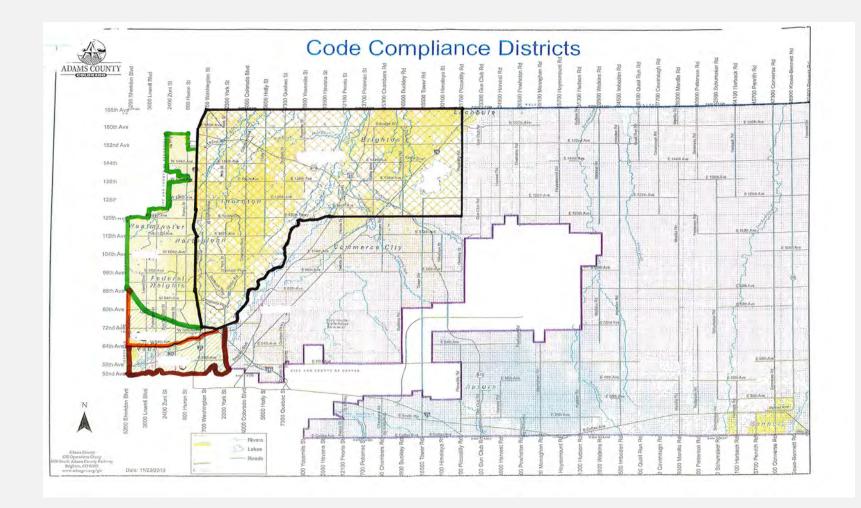

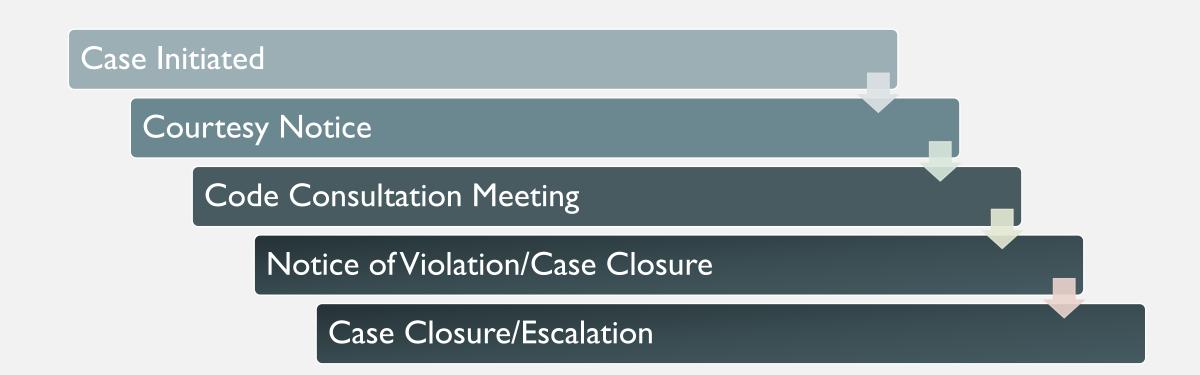

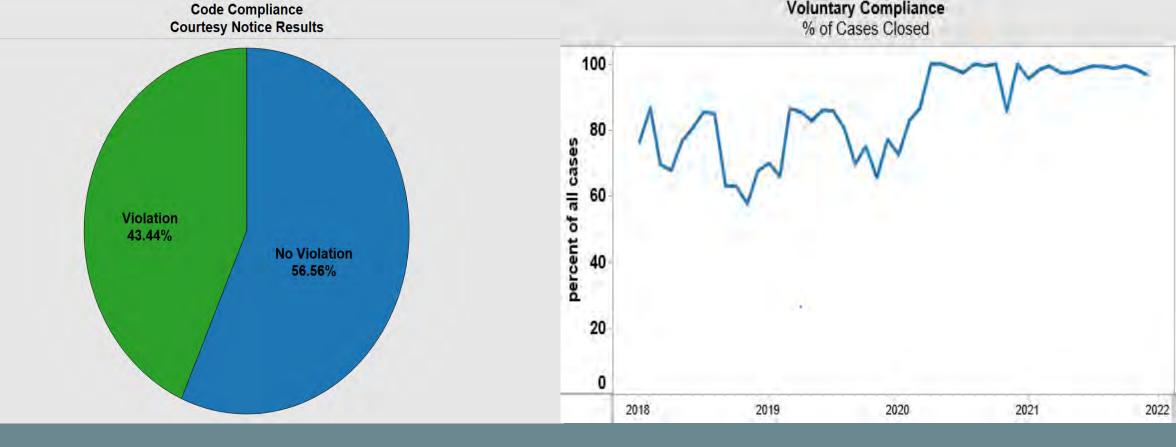
CODE COMPLIANCE DISTRICTS

- Development of neighborhood parking districts for those in most need of parking access relief



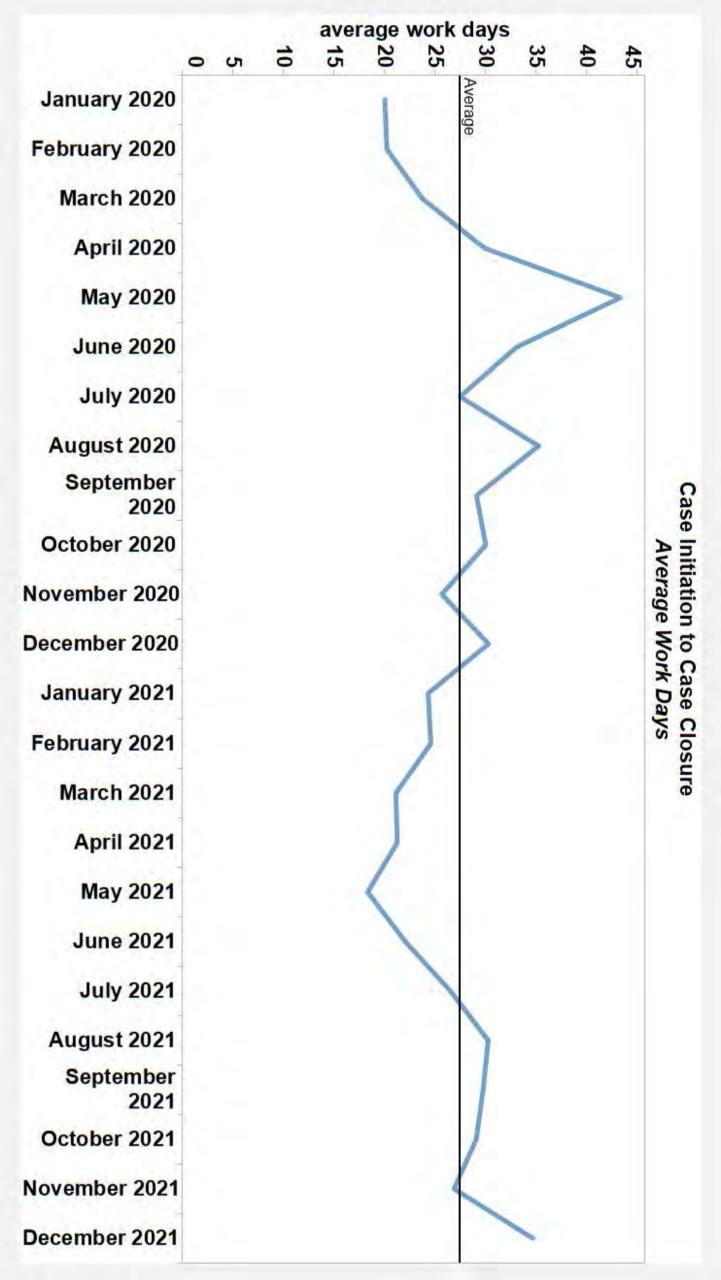

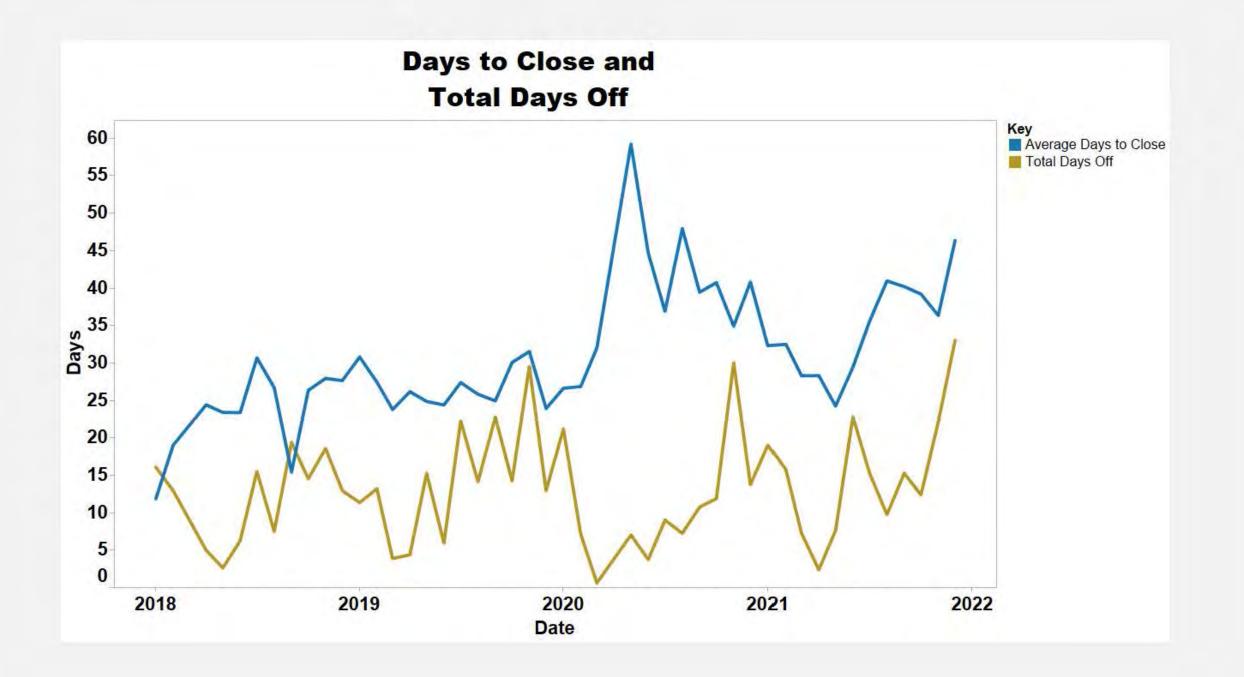
