VIII. SCFD Update – Dana Manyothane

- a. SCFD Revenue Report: The December 2022 SCFD sales and use tax revenue was \$8,073,128.61. This brings the total Fiscal Year (FY) 2022 sales and use tax revenue to \$85,755,983.39. This compares to FY 2021 sales and use tax revenue of \$76,394,351.23. The variance is \$9,361,632.16, a 12.25% increase in FY 2022 over FY 2021
- b. Virtual Attendance: Language about virtual attendance has been inserted into County grant guidelines and communicated to Tier III organizations. Beginning this grant cycle, virtual attendance will not be counted. Organizations may still produce hybrid programs, but funding can only support in person costs.
- c. Office Hours & Updates: Physical office by appointment only. Staff is working Hybrid schedule (in office/at home) until further notice: Monday thru Thursday 8:00am 6:00pm.
